IMMIGRATION DECREE

*(Cap 93)***Immigration Decree (Amendment) Regulations, 2014**

In exercise of powers conferred by section 29 of the Immigration Decree, the Minister of Home Affairs and Transport, makes the following Regulations—

1. These Regulations may be cited as the Immigration Decree (Amendment) Regulations, 2014. Citation

2. The Immigration Regulations is amended as follows— Amendment of Schedule
 - (a) by repealing in paragraph (d) the word “or” and by repealing paragraph (e) in regulation 5, and substituting therefor the following paragraph—

“(e) permanent residence permit under section 17A; or
 - (f) the variation of any term or condition of a permit;”;

 - (b) in the First Schedule by inserting after Form IMM/14 the following Forms—
