

**S.I 23 of 2015****CUSTOMS MANAGEMENT ACT, 2011***(Act 22 of 2011)***Customs Management (Southern African Development Community Free Trade Area) Regulations, 2015**

In exercise of the powers conferred by section 270 read with section 272(1) of the Customs Management Act, 2011, the Minister of Finance, Trade and The Blue Economy hereby makes the following Regulations —

1. These Regulations may be cited as the Customs Management (Southern African Development Community Free Trade Area) Regulations, 2015. Citation

2. In these regulations, unless the context otherwise requires — Interpretation

- (a) “certificate of origin” means certificate of origin issued in accordance with the provisions of the Treaty;
- (b) “Member State” means a member state of the SADC FTA;
- (c) “Protocol on Trade” means the Protocol on Trade in the Southern African Development Community (SADC) Region passed on 24th August, 1996, as amended from time to time;
- (d) “SADC FTA” means the Free Trade Area in the Southern African Development Community (SADC) region established in August, 2008;

- (e) “Treaty” means the Treaty of the Southern African Development Community (SADC), done at Windhoek, Namibia, on the 17th day of August, 1992.

Application **3.** These Regulations apply to Member States listed under Schedule 1.

Customs duty in respect of goods originating from a Member State **4.(1)** The Customs duty on the goods listed under Schedule 2 shall be payable at the rates specified under the Customs Management (Tariff and Classification of Goods) Regulations, 2014.

(2) The Customs duty on the goods listed under Schedule 3 or Schedule 4 shall be payable at the rates specified in those Schedules, respectively, if the goods —

- (a) originate from a Member State, in accordance with the Protocol on Trade; and
- (b) are supported by a certificate of origin,

subject to condition that the Member State extends similar treatment to the import of goods from Seychelles.

(3) The rates of Customs duty payable for the goods listed under Schedule 4 shall, in respect of a year, be as indicated under columns 4 to 11, as the case may be.

Refusal of certificate by Assistant Commissioner of Customs

**5.(1)** The Assistant Commissioner of Customs may, where the certificate of origin is incomplete or he has reason to believe that the certificate of origin is forged or fabricated, refuse to accept the certificate for the purposes of these Regulations and declare the certificate to be invalid.

(2) Where a certificate of origin is declared to be invalid under subregulation (1), the provisions of the Customs Management (Tariff and Classification of Goods) Regulations, 2014 shall, in respect of the goods to which such certificate relate, apply.
